### Klamath County Fairgrounds

One of the "S" in SPICES for Quakers is for stewardship, particularly stewardship of the earth. Klamath County will have a meeting at 6 PM - 8PM o August 27 at the Fairgrounds to discuss renaming Exclusive Farm Use Land for a garbage dump. This dump is planned for the marshlands which are sensitive and necessary wetlands for aquifers, rivers, lakes, and drinking water, not to mention home to many kinds of wildlife. Exclusive Farm Use means the land is protected for agricultural purposes including to protect forests, scenic resources, fish and wildlife habitats, and to maintain and improve the guality of air, water, and land resources of that area. The Klamath Tribes strongly oppose this landfill being placed where they have garnered \$2 million to begin to restore the marsh and are looking to gain another \$3 million in the spring for restoration of this marsh. Extensive research has shown that placing a landfill close to Klamath Marsh would irrevocably damage it and its ecological functions. It has a high water table and is vulnerable to leachate, liquid run off after rains. This marsh is important to the Williamson River, Upper Klamath Lake, and Klamath Marsh National Wildlife Refuge.

Dear friends!

Sunday, before worship, an attender wondered if all the Quakers across the country could pray at a designated time for political peace and election violence prevention? She could see the spiritual power that would flow from a gathered, focused channel of Divine Presence across our country. And as she wondered

aloud, she was sure that if her friends of other denominations and faiths knew that Quakers were praying, they would also want to join in.

As this vision was shared, it was suggested that we begin immediately. Every noon we, at North Seattle Friends, will pray to interrupt the spirit/energy of violence with whatever mode of Spirit is natural to us — prayer, imagery, meditation, silence, etc. We will seek to replace the energy of violence with the energy of Love, Goodness, and Holy Illumination. Our focused time will be as short or long as we are Led and have space for, whether it is a moment between chores or the spaciousness of a dedicated time. We will know that these are not just our singular prayers, but the kindling of a greater, gathered community.

And so it is our joy to invite you and your Meeting/Church to join us in prayer at noon each day. We encourage you to send on this invitation to anyone and everyone, across denominations and faiths. We are not alone in our yearning for peace and hope you and many others will join us. We invite you to take up the challenge not with fear for the future, but with joyous expectation and hope!
