

Featuring three artists, Sue Graves, Natalia Loveness and Sarah Rogers. Sue is an active member of Klamath Falls Friends Church, and helps with Art and Spirituality classes.

Sue Graves has enjoyed being a creative person her entire life. She was raised in lowa and is the seventh of eleven children. Sue learned early on the value of family connections and traditions, but also the importance of individuality and self-expression. As a photographer, jeweler and assemblage artist, her creations reflect the wonders of nature, the exploration of design and color, and the desire to connect to the viewer in a meaningful or whimsical way. Depending on her inspiration, she employs a variety of materials such as beads, gifts of nature, found objects, photographs and semiprecious stones.

She believes that every form of self-expression provides both the artist and the observer an opportunity to encounter beauty, curiosity, meaning and delight. Sue's creations challenge us to look deeper, beyond the everyday significance of the elements within the piece. Her work has been displayed at the Lava Lands Visitor Center, Silver Falls State Park, Ashland Mountain Supply and

There will be a hearing on the county proposed

Landfill August 27, 2024, 6-8 PM at the Klamath County Fair Grounds. This is a hearing on the proposal for a landfill to be placed in Klamath Marsh in an area of the county designated for Farm Use. The Klamath Tribes have spent millions of dollars working to restore the environmentally important marsh. The hearing to change the designation (allow conditional use other than agricultural and exclusively farm use) of the area has been moved to August 27, 2024, 6-8 PM at the Klamath County Fair Grounds. If the landfill is built in the area of the marsh, the leachate would negatively affect the Williamson River, Upper Klamath Lake, and the Klamath Marsh National Wildlife Refuge. The county commission is looking to make a final decision on the landfill and its placement in the marsh directly after this meeting.
