Klamath Unitarian Universalist Church, Klamath Falls Friends Church, Klamath Lutheran Church and Hope Lutheran Church have combined efforts to form an interfaith food pantry using the facilities at Klamath Lutheran Church and volunteers from all four churches. Tune in to the spiritual presence and touch the transcendental soul. Dive into guided meditations and holy mantras that awaken deeper realization. Bask in soul-stirring music, explore profound states of consciousness, and look into the Essential Nature of Life.

September 29, 2024

Presiding Clerk - Bernie K.

Bernie provided a prayer that led the group into centering down.

Gathering/Teaching Moment:

"Discernment" is not the same as voting or consensus. It is based on each person's inner guidance and teaching that leads the group to reach unity.

Ministry and Care - Clerk Wendy W.

Joe and Leigh continue to be in conversation with SCYMF regarding their Recording status. They will provide updates in their Pastors' Reports. M&C has been given feedback about the Membership Process and Covenant which leads them to consider amending the Membership Covenant. There will be a Circle of Friends on October 20 to discuss membership and what it means to be a part of KFFC. Joe and Leigh are encouraged to share Quaker history regarding the difference between being a Member compared to being an Attendee. The input from our Fellowship will assist M&C in rewording the Membership Covenant, if it is to be amended.

There will be a book group in January: Sarah will lead attendees in reviewing Quaker Ecology. More information will be provided.

## **Discussion/Discernment**

A potluck is scheduled for October 13. M&C checked in with meeting members regarding how often they want KFF to hold potlucks. Discussion included suggestions of monthly, every other month, or quarterly potlucks. It was noted that no one is required to attend every potluck and/or bring food to share. Group Discernment led to the Recommendation of holding the October Potluck, then a November Thanksgiving meal together, and reviewing the matter again after the first of the year.

The Recommendation will be discussed by M&C.

We have volunteers that will help with trimming our trees.

Mike is investigating monthly garbage pickup rather than weekly, and once per month janitorial services for the upstairs.

Stewardship minute recommendation for Sept. 29, 2024 KFFC Business Meeting

- \* Klamath Falls Friends Church approves the following changes to its registry for the Oregon Secretary of State Corporation Division and to its records at Umpqua Bank in order to add Margo McCullough as an Umpqua Bank account signer and to remove Linda Warner as an Umpqua Bank account signer:
- 1. Remove Linda Warner as the Registered Agent for the Oregon Secretary of State Corporation Division and add Michael Moore as the Registered Agent for the Oregon Secretary of State Corporation Division.
  - 2. Add Margo McCullough as the Treasurer to the Oregon Secretary of State Corporation Division registry and to the records for Umpqua Bank.
    - 3. Remove Linda Warner as a signer and in any capacity at Umpqua Bank.
- \* Klamath Falls Friends Church (KFFC) approves removing Linda Warner as a signer and in any capacity at Edward Jones where KFFC holds certificates of deposit accounts.

Informational:

The Food Pantry Open House will be held on October 18th. They are requesting assistance with cleaning the Pantry (October 7th at 10:00 a.m....bring a lunch) and with providing finger foods for the event.

Thanksgiving food box forms were distributed to Pantry attendees; 70 families signed up. Sherm's grocery store is providing vouchers for turkeys, and a list of Thanksgiving food items will be distributed. Each of the four churches will be responsible for a percentage of the 70 food boxes, based on membership size.

The Food Pantry will be collecting donated sleeping bags and blankets during the months of October and November.

In December, the Food Pantry will be open earlier in the month, due to the Christmas holiday.

The Peace Supper and presentation by Nicole Sanchez was well-attended, with half KFFC members and half non-members, many from the UU church. Nicole (of the Extension Office) received a \$35.00 donation for their turf replacement program.

The Mom's Rising GOTV (Get Out The Vote) postcard mailing activity will be held after the KFFC October 6th service. We will write words of encouragement to those receiving the postcards.

## **Discussion/Discernment:**

KFFC P&SC had recommended placing a banner on the side of our building that reads "Love More, Fear Less". The banner was ordered; it is an approximately 3' by 9' white on purple banner with the words "John 4:18 There is no Fear in Love".

The final Prayer Vigil led by Joe will be Wednesday, October 2nd at 5:30.

The Landfill Project is not going forward as of now; we will monitor the situation on a regular basis. A KFFC Position Letter was sent to the Klamath County Planning Commission and the Tribal Administration.
